AN ACT Relating to modifying the dates on which a special election may be held; amending RCW 29A.04.321, 29A.04.321, 29A.04.330, and 29A.04.330; providing an effective date; and providing an expiration date.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

6 **Sec. 1.** RCW 29A.04.321 and 2006 c 344 s 2 are each amended to read 7 as follows:

8 (1) All state, county, city, town, and district general elections for the election of federal, state, legislative, judicial, county, 9 10 city, town, and district officers, and for the submission to the voters of the state, county, city, town, or district of any measure for their 11 12 adoption and approval or rejection, shall be held on the first Tuesday after the first Monday of November, in the year in which they may be 13 14 called. A statewide general election shall be held on the first Tuesday after the first Monday of November of each year. However, the 15 statewide general election held in odd-numbered years shall be limited 16 to (a) city, town, and district general elections as provided for in 17 18 RCW 29A.04.330, or as otherwise provided by law; (b) the election of 19 federal officers for the remainder of any unexpired terms in the

membership of either branch of the Congress of the United States; (c) 1 2 the election of state and county officers for the remainder of any unexpired terms of offices created by or whose duties are described in 3 Article II, section 15, Article III, sections 16, 17, 19, 20, 21, 22, 4 5 and 23, and Article IV, sections 3 and 5 of the state Constitution and RCW 2.06.080; (d) the election of county officers in any county 6 7 governed by a charter containing provisions calling for general county elections at this time; and (e) the approval or rejection of state 8 measures, including proposed constitutional amendments, matters 9 pertaining to any proposed constitutional convention, initiative 10 11 measures and referendum measures proposed by the electorate, referendum bills, and any other matter provided by the legislature for submission 12 13 to the electorate.

14 (2) A county legislative authority may call a special county 15 election by presenting a resolution to the county auditor prior to the 16 proposed election date. ((Except as provided in subsection (4) of this 17 section,)) <u>A</u> special election called by the county legislative 18 authority shall be held on one of the following dates as decided by 19 such governing body:

A resolution calling for a special election on a date set forth in subsection  $(2)((\frac{d}{}))$  (d) or  $((\frac{f}{}))$ (e) of this section must be presented to the county auditor at least eighty-four days prior to the election date.
